In October we had the most successful Central Florida Real Estate Forum to date and we are already actively preparing for next years' 8th Annual CFREF. Our Chapter has set up a Project Team, led by Walter Carpenter in order to address concerns and identify problem areas and solutions upon reviewing the AI Proposed Governance Restructure Project. Their findings and recommendations will be summarized and submitted to our Board of Directors. At our January 25 Board of Directors Meeting we will be selecting a third person to added LDAC. The Region X Meeting is scheduled for Monday 1:00 pm, January 15 at the Four Points by Sheraton Tallahassee Downtown. There will be a Reception after the meeting, geared towards legislative overview, proposed bills, what's going on in Tallahassee and networking. The meeting is followed by the third annual Valuation-Appraisal Legislative Event (VALUEvent) in Tallahassee on Tuesday morning, Jan. 16. Any AI member in Florida is encouraged to attend (no cost for Region X members) and it counts for 2 hours (10 points) AI CE credit. We will be reaching out to our State Representatives about current topics and legislation affecting our industry. As leaders in advocacy efforts on behalf of real estate appraisers, this will be another year where the participation of Appraisal Institute members is of vital importance.
